Why did you place yourself on the spectrum where you did?

Labels can be divisive, but it is important that I not be lukewarm. For the Lord says that there is nothing worse than being lukewarm. It is my duty as a Christian to love liberally and everyone without hesitation. That means the most broken of us. I have to ask myself which theology provides for the poor? For the most broken or ostracized in our world? Especially in the light of oppression that we as Christians have been guilty of perpetuating. It is in modern liberation theology I find these answers and my charge to seek justice for everyone. This shouldn't be an issue of labels, but I have come to associate this theology with certain people who identify with the label chosen above. So if I am liberal because I seek justice and love on earth through the love of Christ for everyone then I am fine with the inevitable sore eyes I will get from those on the other end of the spectrum....also theology is not stagnant nor should the original standards from 2000 years ago define the absolute laws of the Church now. At the point at which we believe in equity and not complementarianism then we need to be liberal in the way the Church is governed.

Please share with the committee what you believe are the key theological/social issues currently facing the church and society, and how they shape your experience in the church: 1.) The issue of church stewardship among more conservative congregations and the claimed biblical authority to leave PC USA. 2.) The continued focus on social justice within the Church becoming a living witness instead of "guilty allyship". I am from a church that split into two during my formative years due to the congregation splitting among Pro-PC USA and Anti- PC USA lines. It left me with a deep sense of mission to keep churches in PC USA and together. I deny the arguments made by those seeking dismissal from the denomination under their claimed "biblical authority and theology" on the basis it destroys the sacred theology of stewardship and brotherly bonds. Secondly, I have seen so many churches in this denomination espouse progressive beliefs without really doing anything beyond optics to support their causes. The church continues to disconnect with my generation not because religion is becoming uncool or more progressive, but because the church maintains a pseudo progressive facade that only marginalizes minorities such as myself and makes it harder for us to feel the presence of the living in God in a congregation. I grew up in a Korean congregation where due to my mixed status I was made to feel inferior by blood. I attended services at a majority white congregation where the same discrimination occurred in reverse. It was only in college when I attended Providence Presbyterian in Providence, RI was I considered a person in my own right, in the image of God. It is through multiculturalism and pluralism that we find God, not in the segregatory churches that have come to make up to much of our denomination.

Please indicate why you want to represent National Capital Presbytery at the General Assembly:

It is my home. It is my home because I found belonging and care in a Presbytery and Church that put justice and God's love above all else. The GA will determine whether we move forward as a church and continue to welcome people like me or whether it takes steps back and leave those who sought shelter, justice, love, and mercy behind. I want to see a church that is uncompromising in its stand for justice and equity, but loving enough to welcome back the wayward congregations that oppose the movement for greater justice blindly with open arms. I want to go because the Capitol Presbytery is one of the more diverse Presbytery's in the country and it should be touted as a vision for continued diversification and reconciliation. These issues matter to me, will determine the future of the Presbytery, and the future of the denomination. I want to represent the voices of the Presbytery as it forges its way into a more equitable Church for all of God's children. And I also want to help put a face to a changing church who needs to continue to seek justice.
