Why did you place yourself on the spectrum where you did? I vote and contribute and work on local and statewide political campaigns. My wife is a healthcare policy expert at AARP. . I serve on boards that advocate and provide servies for addiction, homelessness, hunger, and improving public education. I am committed to inclusiveness. My congregation is increasingly multicultural and this greatly enriches our fellowship. I am committed to reaching the next generation of Americans thorugh worship that is relevant and culturally sensitive (we have rock band for one service). I believe that the scriptures are the Word of God and must be taken seriously. People are very lonely and we must preach and live the Incarnational truth that God is with us.

I think the church must speak to the pressing issues of the day: climate change, racism, poverty, militarism, access to health care and education, and gun violence. This must be done without getting caught up in the partisan rancor of our time. This is hard work. The Presbyterian Church must be careful in the preseciptions they offer to issues of injustice. It is not helpful to take a vote on a complicated and controversial public issue-then make a declarative announcement when the vote is 52-48%. We are not Congress . What does scripture incline us to do? The church must be an agent of healing: body mind and soul. It must seek first to understand, before we seek to be understood.

Please share with the committee what you believe are the key theological/social issues currently facing the church and society, and how they shape your experience in the church: The church must preach good news-not just offer good advice. Number one is reaching the next two generations of Americans. The Christian Church does not have an attractive image in America. It is often viewed by outsiders as racist, anti-gay, misoginistic, and anti-science (denial of climate change). Yet, there is a hunger to know Christ and be part of an authentic community that loves one another, and engages a hurting world with acts of compassion. The church will continue to seem irrelevant to people outside our walls if we are not engaged in making a real different. Please indicate why you want to represent National Capital Presbytery at the General Assembly: I have never served as a commissioner to General Assembly. I attended part of the Assembly when it met in Baltimore. I love the worship. I enjoy working together with deeply committed fellowers of Jesus. I desire to connect with Presbyterians who serve Christ in other contexts. I don't have any pet issue that motivates my application. I think I bring a broad understanding and wealth of experience as a Teaching Elder. I love the Presbyterian Church and desire to serve it faithfully.
