## **Contextual Statistics**

# **Total Membership for 2018**

26,923 Active Members (A decrease of 1,332 Active Members from 2017)

# Gender

- Of 26,923 Active Members, 59.5% are female
- Of 194 Leadership Roles, 45.9% were fulfilled by females

# Age

- Of 3,973 Active Members 25 years old and under, 0 serve in NCP Leadership positions
- Of 11,064 Active Members 26-65 years old , 144 serve in NCP Leadership positions (An increase of 1 from 2017)
- Of 11,886 Active Members 65+ years old, 50 serve in NCP Leadership positions (A decrease of 9 from 2017)

## **Ethnicity**

- Of the 26,923 Active Members, during 2018 there were 194 Leadership positions
  - 1. 3.8% of Active Members were Asian American with 7.2% serving in Leadership positions
  - 2. 14.6% of Active Members were African American or African with 14.4% serving in Leadership positions
  - 3. Less than 1% of Active Members were Hispanic or Latino with less than 1% serving in Leadership positions
  - 4. There were also 83 Middle Eastern/North African members and 13 Native
    American persons. These groups were not represented in NCP Leadership positions in 2018
  - 5. 22.2% of overall Leadership Positions are held by people other than Caucasian
  - 6. 2 of 13 members of Leadership Council are other than Caucasian (15.4%)
