A Word on the Budget Process

For planning purposes, our churches can plan on the per capita amount remaining the same for the 2022 fiscal year. In a change from recent history, **our work at this September meeting will not include a "first reading" of the budget**. One learning in this COVID time is that we can use our common meeting time on zoom more efficiently by allowing you to have more control of the amount of information you need in order to make an informed decision. In lieu of a "first reading," Budget and Finance will provide information about the budget in a variety of formats, and well in advance of our November meeting. These ways will include:

- 1. An itemized budget
- 2. A narrative budget that tells the story of how that budget supports our mission
- 3. A video overview on the budget process to be watched (and re-watched!) at your leisure
- 4. An Open Space before the November meeting to answer any questions or concerns that you may have on the budget
- 5. In addition, if you are unable to attend that Open Space, you can reach out in advance to our presbytery staff to ask questions or raise concerns.

NCP leadership believes that all of those opportunities to review the information, ask questions, and offer feedback will provide better preparation for a vote on the budget in November.

ACTION ITEMS FOR SEPTEMBER 28, 2021 NCP MEETING

Motion: To approve the recommendation from the NCP Leadership Council to commission Ruling Elders to serve specific pastoral roles in NCP congregations or fellowships and grant authority to COM to appoint a team to prepare applicants to be commissioned by NCP to serve a particular congregation or fellowship for a particular time.

Background

On Feb. 3, 2021 the NCP Leadership Council approved the appointment of a Task Force to research and make recommendations for developing a process for commissioning Ruling Elders who have been trained to provide specific pastoral duties in NCP congregations. The Commissioned Ruling Elder Task Force (CRETF) includes Carolyn Fink, Warren Clayton, Kris Obom Maldarelli and staff resource, Jan Moody. The team reviewed CRE program manuals from the presbyteries of Baltimore, Geneva, Minnesota Valleys, Sheppards and Lapsley, Tampa Bay, East Iowa, Coastal Carolina and studied the training programs for CREs offered at Dubuque and Union seminaries. The team interviewed several NCP ministers who have served in presbyteries that commission Ruling Elders and gleaned the variety of ways that CREs can enhance ministries in congregations. After consultation with COM and NCP staff, the team identified more than ten NCP congregations for whom a CRE could potentially provide needed pastoral leadership.

Why Commission Ruling Elders (CREs?)

A Commissioned Ruling Elder) is a calling acknowledged by the Book of Order to ministry within the PC (USA). Using their God given gifts and talents, along with appropriate training, CREs may serve congregations and ministries within the presbytery to be faithful in Word, Sacrament and Reformed faith.

What is a Commissioned Ruling Elder?

A CRE is an elder in the Presbyterian Church (USA) who is granted a local commission by the Presbytery to limited pastoral service as assigned by the presbytery. Commissioned ruling elders(CREs) are trained to provide specific pastoral functions. Areas of study include:

- Biblical Studies
- Reformed Theology and Sacraments
- Presbyterian Polity
- Preaching
- Leading Worship (including administering sacraments when authorized)
- Pastoral Care
- Field Internship

CREs are commissioned by the NCP to a NCP congregation or fellowship for a particular time. That commission is reviewed annually.

What is the ruling elder commissioned to do?

A CRE may moderate the session of the congregation to which he or she is commissioned and administer the Sacraments. A CRE provides for the worship and nurture of the congregation. Permission for specific activities will be included in the contract established between the session of a particular church, with the approval and supervision of the Committee on Ministry. (See G-2.1001, Book of Order)

Motion: To approve, by three-fourths vote, the recommendation from the Commission on Preparation for Ministry to waive the time limitations of G-20602 that requires a 2-year minimum process for the inquiry and candidacy phases of readiness to receive a call for Candidate Emilee Williams,

Background

Emilee Williams received a Master of Divinity from Princeton Seminary in 2018. Following graduation, she began exploring the process for ordination as a Minister of Word and Sacrament in the PCUSA. She joined Bush Hill Presbyterian Church and was encouraged by her minister and session to apply to become an inquirer under the care of CPM.

She wrote in her application to become an inquirer,

"Following seminary, I pursued a call in Campus Ministry as the Director of Community & Spiritual Growth, knowing ordination was a possibility. As I began working closely with Presbyterian congregations, I realized I had finally found my denominational home."

She is in her fourth year as the Director for Community & Spiritual Growth at Arise Campus Ministry, the Protestant college ministry at George Mason University and Northern Virginia Community Colleges. She started in July of 2018 following graduation from seminary and has spent her time there growing and redeveloping the ministry. Currently, Arise is thriving being back in person and is seeing great response to their fall mission of reclaiming community, connection, and conversation on campus with God and one another.

She enrolled as an inquirer in November 2020 and was moved to candidacy in March 2021. In February 2021 she passed the Bible Content Exam and in April 2021 she passed all four of the senior ordination exams. In the summer of 2021, she completed a course in Biblical Hebrew. On September 16, CPM approved her as ready for final assessment to be certified as ready to

receive a call in October 2021 pending approval of a waiver of G-20602 by NCP at its September 28, 2021 meeting..
