

## **Policy on Parish Associate Relationships**

## **National Capital Presbytery**

A parish associate is a specialized teaching elder, at-large, or honorably retired teaching elder member of National Capital Presbytery who wishes to associate with a particular congregation. This is a temporary position. The annual, one year term renewable relationship, shall be established, upon nomination by the installed or temporary pastor, between the parish associate, the session, and the presbytery. A Parish Associate has neither voice nor vote on the session. Ordinarily, a candidate cannot be ordained to this position. The parish associate shall be responsible to the installed or temporary pastor, as head of staff, and may serve on an "as needed, and available" basis without remuneration.<sup>1</sup> Parish associates can receive honoraria for specific tasks.

May Not Be Next Installed Pastor: A parish associate may not be called to be the next installed pastor or associate pastor of a church served as parish associate, unless at least one year has elapsed since the end of the parish associate relationship.

Termination of the Relationship: The annual agreement between the session, the parish associate, and the presbytery shall terminate when the call to the installed or temporary pastor is dissolved. The presbytery may dissolve the relationship with the parish associate upon the recommendation of the session and its moderator and a vote from the Coordinating Commission of the Committee on Ministry.
