Leadership Council (LC) Chair, Dave McClung opened the meeting with prayer at 12:32 PM. Rev. Sterling Morse offered a devotion based on Micah 6:8 and offered for LC to "act justly, walk humbly, love mercy with our God."

Dick Riegel presented Administrative Commission on Congregational Property's (ACCP) annual report. (The report will be available on the NCP website.) Dick acknowledged and thanked Heather Deacon for her timeliness and preparedness. Leadership Council received the report with gratitude.

Molly Casteel, PCUSA's Assistant Stated Clerk, Manager for Equity and Representation and IDI Qualified Administrator, reported on the group's findings. Leadership Council (LC) Chair, Dave McClung opened the meeting with prayer at 12:31 PM. Rev. Diane Hendricks offered a meditation by Rev. Emily Swann, co-founder and co-pastor of Blue Ocean Church in Ann Arbor, Michigan based on Habakkuk 2:20.

Rev. Ashley Goff shared the money story of Arlington Presbyterian Church and how the church used the money to do God's work. Dave McClung presented the motion:

Stated Clerk, Jan Moody, gave an update about Commissioned Ruling Elders. The Committee on Ministry is drafting a CRE manual. Currently, there are five Ruling Elders enrolled in the CRE program.

Following the last the LC meeting, the LC chair approved an eVote for a motion to recommend the addition of a new standing rule relating to the cancellation of presbytery meetings. The eVote took place on March 10, 2022. The motion was approved by eVote and will be presented at the March Presbytery meeting for consideration by the Presbytery.

**Motion:** Leadership Council moves to approve the following Standing Rule for National Capital Presbytery:

### **Standing Rule #7**

An ad hoc Executive Committee is empowered to consider the cancellation of a scheduled NCP Stated Meeting for circumstances not provided for in Standing Rule 2. The ad hoc committee will include:

- The General Presbyter
- The Stated Clerk
- The Moderator of Presbytery
- The Vice Moderator of Presbytery
- The Chairperson of Leadership Council

A majority in favor of cancellation will suffice to cancel a meeting.

Items of business of the cancelled meeting will be considered at the next scheduled NCP Stated Meeting. The General Presbyter is authorized to determine the most effective means of notification of cancellation of a meeting to the presbytery.

## **Background**

NCP Standing Rule # 2, adopted in 2009, provides for cancellation because of weather-related factors or other emergencies which would make travel to/from a presbytery meeting hazardous. The proposed Standing Rule # 7 provides for consideration of additional circumstances that may indicate a reason to cancel a scheduled Stated Meeting of NCP.

For example, if the General Assembly is scheduled to gather at the same time as a scheduled NCP Stated Meeting, this may be a circumstance that indicates a need to consider cancelling the scheduled NCP Stated Meeti
