At 12:30 PM, Leadership Council (CL) Chair, Rev. Dr. Diane Walton Hendricks, called the LC meeting to order and opened with prayer. Elder Miriam Dewhurst provided the devotion based on Thessalonians 5:16-24.

Dr. Hendricks welcomed new Leadership Council members, Rev. Dr. Chris Deacon and Rev. David Douthett and LC looks forward to their service.

Budget & Finance Chair, Elder Eric Kloster, presented the Operating and Mission Budgets for 2023.

Budget and Finance Recommendation:

The NCP Budget and Finance Committee recommends to the Leadership Council a \$1,116,639.17 operating budget for 2023, which reflects the following change in per capita rates from 2022.

Motion: The Leadership Council moves to approve Rev. Shelby Ethridge Harasty and Rev. David Milam as new members to the Nominating Committee. *Approved*

LC reviewed evaluation responses following the September 27 stated presbytery meeting. The November meeting begins via Zoom at 5:00 PM and will focus on the 2023 Operating and Mission Budgets. Noted that evaluations are taken seriously, and comments are addressed by the appropriate NCP staff member if needed. Elder McIlwain was commended on her first presbytery meeting with full support of LC.

Rev. Dr Perzavia Praylow, requested new business and recommended that Leadership Council act intentionally in supporting our African American churches. It was suggested by Leadership Council for John Molina-Moore first reach out to Rev. Denise Anderson and Dr. Perzavia Praylow to see what they

had in mind before we start doing things and get a sense of direction before we act.

Updates:

Rev. Brian Clark updated LC on Faith Chapel. Activity at Faith Chapel has increased significantly. We are seeing community ownership and trying to establish a new worshipping community of NCP.

Elder Shani McIlwain reported a Garden Memorial AC is just about filled. Those who have agreed include Rev. Bernice Parker-Jones (chair), Rev. Ruth Hamilton, Rev. Mark Gaskill, Elder Sandra Barrett (Garden Memorial) and waiting on two others. AC will report back to LC in October and December.

Rev. John Molina-Moore reported the Stated Clerk Search Team has been at work. Requested written responses by four finalists. Team will meet on Monday, October 17 to discuss. Team plans to have interviews through October/November and potentially have a meet and greet prior to the November presbytery meeting.

Attending to Churches in Need is NCPs roll in proactively keeping up with the needs of churches who may be in need.

Dr. Hendricks proposed a LC Strategic Meeting to think more creatively. The meeting will begin with business followed by generative conversation and lunch. Mark calendars for January 11, 2023 from 9:00 AM to 3:00 PM for an in person gathering at a central location.

Dr. Hendricks asked for new business. Rev. Tara Spuhler McCabe called attention the variety of gatherings NCP is providing for pastors and laity. LC is encouraged to spread the word as well as take advantage of these opportunities.

Motion:

Leadership Council moves to approve the granting of a perpetual exclusive easement of the portion of the property located at 14188 & 14185 Chapel Lane, Lucketts, VA, as outlined in the Exhibit A of the Deed of Easement and Agreement to QLoop, LLC for the purpose of laying fiberoptic cable in exchange for \$13,000. Proceeds from this transaction to go towards physical upkeep of aforementioned property. Leadership Council authorizes National Capital Presbytery (NCP) Treasurer to sign on behalf of NCP for matters pertaining to this transaction. *Approved*

Background Information:

Brian Clark has brought forward a request from QLoop to grant an easement on the Faith Chapel property in Lucketts, VA. The purpose of the easement is to lay fiberoptic cable – as part of a 43-mile ring connecting Frederick, MD and Ashburn, VA. (More about the project: https://guantumloophole.com/gloop/).

The Lucketts property is a 3.23 acre parcel which fronts Lucketts Road and is bisected by Chapel Lane. We have recently been made aware that our property also includes a very thin strip of land on the other side of Lucketts Road. That portion of the property is unusable because it is just a setback from the road.

QLoop has approached the folks at Riverside about granting an easement along that thin strip of property along the *other* side (opposite of the church) of Lucketts Rd. Through negotiations, Riverside was able to get them to come up from their initial offer of \$1,000 to an offer of \$10,000. This week, they included an additional \$3,000 if we could sign off on the letter of intent by Thursday (today). This is particularly timely because the Faith Chapel property (which is currently being used as a community center under the direction of Riverside Church) needs a new roof.

There will be an Action Item Dialogue about the Operating and Mission Budgets on Monday, November 14, 2022 at 7:30 PM. Rev. Molina-Moore spoke with both Rev. Denise Anderson and Rev. Dr. Perzavia Praylow about NCP's support of our African American churches. A meeting will be scheduled between Rev. Molina-Moore, Rev. Anderson, Dr. Praylow and someone at the national level at PCUSA.

Rev. Brian Clark, Chair of the Stated Clerk Search Team, gave an update on the progress. The team has narrowed the search to three and all three are good prospects.

General Presbyter, Rev. John Molina-Moore, lifted up churches that need some attention. The General Presbyter reminded us of what the realignment might look like and there will be a discussion about it at the next LC Retreat on January 11, 2023 from 10:00 am to 3:00 pm. Location TBD.

LC Chair, Dr. Hendricks, asked for new business. Rev. Tara Spuhler McCabe, Director of Congregational Development and Mission, announced the enthusiasm around the Youth retreat, Keep Awake.

Dr. Hendricks is concerned about loneliness and disconnection among colleagues. LC members offered regional gatherings in January: Rev. Brian Clark offered for VA, Rev. Dr. Chris Deacon offered in MD, Rev. Nancy Neal and Elder Miriam Dewhurst offered for DC.

LC members requested an NCP recorded service for New Year's Eve. Rev. John Molina-Moore and Rev. Tara Spuhler McCabe can make that happen.
