**Motion:** To approve the Stated Clerk Search Committee's nomination of Rev. David Baer as Stated Clerk of National Capital Presbytery for a term of five years beginning February 1, 2023.

#### **Recommendations from Commission on the Preparation for Ministry**

#### Expedited candidate process for Courtney Vereide

**Motion #1:** The Commission on Preparation for Ministry moves that Courtney Vereide be allowed to enter the expedited candidate process according to the Book of Order G-20610 *"When a Presbytery concludes there are good and sufficient reasons for accommodation to the particular circumstances of an individual seeking ordination, it may by three-fourth vote, waive any of the requirements for ordination in G-2.06, except G-2.0607d (ordination exams)."* 

The expediated process simply removes the 2-year time requirement. Since Courtney has already completed her Master of Divinity degree, CPM is recommending that we waive the twoyear requirement so that she can take her ordination exams and be certified ready for ministry within the next year. She is a candidate in good standing with Vienna Presbyterian Church and is under care of the National Capital Presbytery's Commission on Preparation for Ministry.

#### Alternate Worship Ordination Exam for Ministry Candidate Samuel Sarpong

**Motion #2:** The Commission on Preparation for Ministry moves that the Presbytery approve an alternative worship ordination exam for Ministry Candidate Samuel Sarpong according to Book of Order G-2.0610.

#### G-2.0610 Accommodation to Particular Circumstances

When a presbytery concludes there are good and sufficient reasons for accommodations to the particular circumstances of an individual seeking ordination, it may, by a three-fourths vote, waive any of the requirements for ordination in G-2.06, except for those of G-2.0607d. If a Presbytery judges that there are good and sufficient reasons why a candidate should not be

required to satisfy the requirements of G-2.0607d, it shall approve by three-fourths vote some alternate means by which to ascertain the readiness of a candidate for ministry in the areas covered by the standard ordination exams. A full account of the reasons for any waiver or alternate means to ascertain readiness shall be included in the minutes of the presbytery and communicated to the presbytery to which an inquirer or candidate may be transferred.

Mr. Sarpong has taken the Worship ordination exam 5 times and not passed. He has passed all the other ordination exams. After reviewing his worship ordination exams, we believe that language and cultural differences are a major factor in his not passing the worship ordination exam. Mr. Sarpong has completed his Seminary Training and received an MDiv from Union Presbyterian Seminary in Richmond Virginia. Mr. Sarpong is currently serving as a student pastor at his home church, Ebenezer Presbyterian Church in Woodbridge Virginia. The worship exam is one of the few remaining obstacles preventing him from full time ordained ministry.

The Commission on Preparation for Ministry would recommend that Rev. Rob Erickson, Elder Alan Wisdom and Rev. Lisa Kenkeremath write the alternate exam to cover the standard areas of the worship ordination exam: 1) Reformed Liturgical Heritage, 2) Constructive Theological Reflection on Worship, and 3) Application for Ministry. All three of the exam writers have been graders for the nationwide PCUSA Ordination Exams. The exam will be administered by three members of the Commission on Preparation for Ministry appointed by the CPM Moderator. The candidate will be given time to prepare for the exam as all candidates do, but the exam will be evaluated through both verbal and written responses and role plays. The candidate will be expected to use all the worship resources required in the standard ordination exam: Book of Order- Directory of Worship, Book of Confessions, Book of Common Worship and demonstrate a Reformed understanding of worship, and the sacraments. Our hope is that this exam format will be a model that can be used for other candidates for whom the standard ordination exams fail to measure a candidate's readiness for ministry because of language, cultural or other communication barriers.

#### **History**

In 2015, Riverdale Presbyterian Church (with approval of Presbytery) sold the worship property located at 6513 Queen's Chapel Rd in Hyattsville to The Word of God Baptist Church. In accordance with our financial policies the proceeds, \$1,805,148 was deposited into a Donor Temporary Restricted Fund of National Capital Presbytery (aka "The Riverdale Fund"). This fund was held for the congregation by NCP and the congregation could access them with approval of Leadership Council and RPC Session.

After the sale of the property, Riverdale PC leased worship space and worked on revitalizing the mission of the church – using proceeds from the sale of that property. Despite an abundance of resources (both money and people support from NCP), Riverdale Presbyterian Church was unable to sustain vitality and ultimately dissolved in 2021. As a result of that action, monies in the Riverdale Fund reverted to National Capital Presbytery.

# **Relevant Policy**

Our financial policies<sup>1</sup> lay out process for proceeds from:

- > Sale of Real Property owned by the Presbytery which is not held for a congregation
  - o Satisfy liabilities
  - o Replenish Property Management Fund up to \$350,000 balance
  - o Remaining funds to appropriate Resurrection Fund
- Sale of Real Property held for a congregation

We do not have policy stating what happens to the funds/assets received from dissolved congregations.

#### **Rationale**

Current balance as of 11/30/22 in the Riverdale Fund is \$1,958,789.12.

Office Fund: Currently has no source of replenishment. Purpose is to supplement operating budget (which impacts per capita rate). Rent is the largest driver of the annual \$175,000 draw. We will not see a reduction in that amount until our 2025 budget. Current balance is approximately \$563,276.16. With no intervention, funds are depleted in 3 years, at same rate of withdrawal (which would be the 2025 budget).

- Retreat Fund:Currently has no source of replenishment and the 2023 draw depletes the fund.Purpose is for an annual retreat for minister members and church ministry staff.
- Ministry Crisis Fund: Replenishment comes primarily from installation services. Purpose is to provide emergency assistance grants or loans to ministers and/or their families. Current cash on hand is \$21,620.66. Below is a summary of contributions and withdrawals since 2015.

- New Growth Fund: Currently has no source of replenishment. Purpose is to provide resources to increase membership and participate in NCP, particularly in new ministries. Annual draw is typically \$200,000 - \$225,000. Current balance is \$1,517,086.21.
- NCP Resurrection: Replenishment source is sale of property not held by a congregation. For example, if a church dissolved and NCP had to sell the property (which is no longer held by the congregation) the proceeds would be earmarked for this fund. This fund directly impacts our mission budget because we draw off of it, annually, to fund the mission budget. Current balance is \$2,782,024.80.

#### **Summary**
