ACTION ITEMS FOR SEPTEMBER 26, 2023 NCP MEETING

ACTION ITEM #1

Recommendation from the Commission on Ministry

MOTION: The Commission on Ministry, pursuant to Book of Order G-2.0504(c) and the Presbytery's Policy on Changes in Pastoral Roles within a Congregation, recommends that the Presbytery **GRANT** an **EXCEPTION** to allow the Rev. Connie Jordan-Haas, who is currently serving as a Stated Supply Associate Pastor at Vienna Presbyterian Church, to be eligible to be called and installed as Associate Pastor.

Rationale: The Book of Order recognizes the special role played by ministers in temporary pastoral relationships, as they work with congregations through periods of transition, and accordingly provides that "[a] minister of Word and Sacrament in a temporary pastoral relationship is *ordinarily* not eligible to serve as the next installed pastor, co-pastor, or associate pastor" (G-2.0504(b), emphasis added). Nonetheless, our polity also recognizes that in certain circumstances, the mission of the church may be better served by allowing a minister serving in a temporary pastoral relationship to make a transition to an installed pastoral relationship. Therefore, G-2.0504(c) allows a presbytery to grant an exception to the ordinary practice, with the approval of at least three quarters of those present and voting.

National Capital Presbytery's Policy on Changes in Pastoral Roles within a Congregation establishes a process whereby a minister in a temporary pastoral relationship who feels called to move to an installed position in the same congregation can work with both the COM and the session to discern whether such a move is appropriate. The minister begins by discussing the transition with representatives of the COM. The Congregational Transitions Commission (CTC), if it approves, then grants permission for the session of the church to begin a period of discernment with the congregation, guided by a number of key questions. In the case of associate pastors moving to an installed role, the questions center on the health of working relationships, the overall health of the congregation, and whether the congregation would prefer to have the opportunity for other candidates to be considered for the role.

If, following the period of discernment, the session wishes to proceed with the transition in role for the minister, it notifies the CTC, which brings the matter to the presbytery for approval under G-2.0504(c).

Vienna Presbyterian experienced an extraordinary loss when the Rev. David Jordan-Haas passed away while serving as Associate Pastor in July 2019. Vienna leaders consulted with COM leadership about hiring the Rev. Connie Jordan-Haas, who already had deep ties with the congregation, to serve as stated supply in the wake of his untimely death. The church was not only dealing with transition of pastor through unexpected death, but also the coming retirement of their Head of Staff, which had already been announced. Vienna's Session felt it would be destabilizing to embark on an extended search process in the wake of this sudden loss and the anticipated retirement of their long-time pastor. Last year, another Associate Pastor departed after the new Head of Staff had been there less than a year, adding to this season of transitions, and increasing the desire of the Session to install Rev. Jordan-Haas, affirm their commitment to their pastoral relationship with her, and express their appreciation of her faithful leadership throughout this time.

Following conversation between the Rev. Connie Jordan-Haas and representatives of the COM, the session of Vienna Presbyterian Church was granted permission to begin discernment with the congregation in June 2023. After considering the feedback they received through this process, they reported the following, in a letter dated August 15, 2023:

With joy we report to you Vienna Presbyterian Church Session's approval today of the exception requested by the Rev. Connie Jordan-Haas to move from her current temporary position as Stated Supply Associate Pastor to become Vienna's called Associate Pastor for Congregational Care and Fellowship. Pastor Connie has served in her temporary position at Vienna since December 2019.

This action was taken only after a period of deep congregational discernment facilitated by a team approved by Session on June 20, 2023, upon our being informed that the Congregational Transitions Commission (CT) had granted approval of this request for an exception. Our team devoted itself energetically to this work over the ensuing weeks. The congregation was fully informed, and its response has been unequivocally enthusiastic and positive.

We appreciate the support and guidance you have provided, which assisted us in fulfilling our important responsibilities. The team's work was intensive and Spirit-filled.

The discernment team and Session itself carried out this work in a manner consistent with and animated by the guidance found in the National Capital Presbytery's (NCP) "Policy on Changes in Pastoral Roles Within a Congregation" and in the NCP (CTC's "Questions for Discernment," July 7, 2016.

We understand that implementation of this action is subject to approval by the full Presbytery, followed by our congregation's election of Pastor Connie to this Associate Pastor position and approval of the Terms of Call. Accordingly, in accordance with the Book of Order, G-20504c, we ask that you arrange for this matter to be brought before the Presbytery for a vote at the earliest opportunity.

Accordingly, the COM recommends that the presbytery grant this exception to the ordinary rule governing eligibility for installed service.

ACTION ITEM #2

Recommendation from the Congregational Development Commission

The Congregation Development Commission **RECOMMENDS** that National Capital Presbytery:

- DECLARE the Emmanuel Indonesian Presbyterian Church to be an organized congregation of this
 presbytery, with its membership constituted by those persons who have signed the attached petition; and
- AUTHORIZE the Congregational Development Commission to carry out the responsibilities of the presbytery under G-1.0201, including:
 - 1. Exercising original jurisdiction as the session of the congregation, until the installation of elders elected by the congregation.
 - 2. Calling a meeting of the congregation to elect officers, and preparing, examining, ordaining, and installing these newly elected persons.
 - 3. Working closely with the congregation and the Commission on Ministry to confirm or secure pastoral leadership.
 - 4. Reviewing the current governing instruments of the congregation, including its incorporation and bylaws, and counseling with the session concerning any adjustments that may be needed to conform to the Constitution of the Presbyterian Church (U.S.A.).
 - 5. Giving other forms of support and encouragement that will strengthen the mission of the congregation in the larger life of the denomination.

Rationale and background:

The *Book of Order* provides for the organizing of new congregations in the following way: Persons wishing to form a new congregation present the organizing covenant in the form laid out in G-1.0201, and the presbytery "at its sole discretion" *may* declare these persons to be an organized congregation of the presbytery. After this declaration, the presbytery continues to provide practical support to the congregation in establishing its governing structures and in choosing its officers and pastoral leadership.

The Emmanuel Indonesian Presbyterian Church (EIPC) was organized as a fellowship. They have worked closely with the CDC, adopting forms of governance in the manner of PCUSA congregations, incorporating under the laws of the State of Maryland and entrusting the oversight of the fellowship to a session of elected elders. The CDC feels that this fellowship is ready to become an organized congregation.

The NCP Manual of Administrative Operations provides that the Congregational Development Commission is to "[e]xercise the powers and assume the responsibilities of a session with jurisdiction over new worshipping communities, fellowships and new church developments as defined by the Church Development Commission" (p. 20). While the CDC also has the responsibility to "[r]ecommend the formation of separate Administrative Commissions to oversee a particular New Church Development through the process of becoming a chartered congregation," we feel that a separate commission is not necessary in this case because EIPC has already accomplished most of the work that is needed.

PETITION

We, the undersigned, in response to the grace of God, desire to be constituted and organized as a congregation of the Presbyterian Church (U.S.A.), to be known as **Emmanuel Indonesian Presbyterian Church**. We promise and covenant to live together in unity and to work together in ministry as disciples of Jesus Christ, bound to him and to one another as a part of the body of Christ in this place according to the principles of faith, mission, and order of the Presbyterian Church (U.S.A.).

The original petition with signatures will be presented at the stated meeting.
