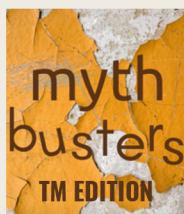

*[Jesus said,] "Which of these three, do you think, was a neighbor to the man who fell into the hands of the robbers?" He said, "The one who showed him mercy."  
Jesus said to him, "Go and do likewise."  
- Luke 10:36-37, NRSV -*

Dear Friends,

The election this week set me to thinking about our role as a church in the days that lie ahead of us, and I keep coming back to Jesus' teaching about love for our neighbors. Not as a platitude, or a nice sentiment, but love for neighbors as a commitment to tend to the most vulnerable among us.

One time a lawyer asked Jesus to tell him what he had to do to inherit eternal life. Jesus told him, "You shall love the Lord your God with all your heart, and with all your soul, and with all your strength, and with all your mind; and your neighbor as yourself." But it seems the man got stuck on the word neighbor. According to the Great Commandment, a neighbor is someone who deserves to be treated on an equal footing and loved in equal measure with oneself. But this is difficult! Surely there must be limits, the man thought. **There must be some place I can draw a circle** and say, "The people inside I will love as myself. They are my neighbors. Everyone else is a stranger, and I don't need to love them as I love myself."

So he asked, "Who is my neighbor?" Maybe he thought Jesus would say, "Your family" or "your village" or "the Jewish nation." Those are understandable boundaries. At the edge of one of these groups, perhaps, the duty to love others as oneself might come to an end.

But **Jesus doesn't give him a boundary, a limit to the commandment to love.** Instead he tells a story, where a hated, feared Samaritan is the one who stops to care for a victim of robbery and violence. The Samaritan does this at risk to himself—he doesn't know where the robbers are, or even that this isn't a trap. He does this for someone he has no affinity with—someone who is not a member of his family or village or nation. (In fact, in Jesus' story, the priest and the Levite, who at least shared his nationality and ethnicity, left the victim for dead.) Jesus asks the lawyer a question of his own, not "Who is my neighbor?" but "Who acted as a neighbor?"

The lawyer answers correctly: "The one who showed him mercy." "Go and do likewise," Jesus says.

I wonder what boundaries we feel tempted to draw as we define our neighborhood, the scope of those we are commanded to love. Is it family? Community? Nation? Or, as with the Good Samaritan, ought the presence of vulnerability or need itself be enough for us to recognize a neighbor?

## From the Desk of Rev. David Baer (continued)

**Jesus won't allow us to build walls or draw borders that put others outside our duty to love them as ourselves.** The good news of Jesus is that despite our sin and unworthiness, God loves and chooses us. God only asks that we turn and lavish the same grace and generosity on others—deserving or not, “one of us” or not, safe or not.

If you are feeling vulnerable at this time, I hope that your church community will meet you with this kind of grace and care. It is good to gather every Sunday to remember Jesus' resurrection, to sing, to hold hands, and to be strengthened to meet whatever the world may impose on us as those who know we are in the keeping of God and of one another.

Maybe your life circumstances are such that your cup is running over right now, and you have time and space to care for neighbors inside and outside the church. May God strengthen you for this ministry. I suspect, though, that most of us fall somewhere in between. Please know that you are not meant to love your neighbor out of your emptiness, but out of the fullness of God poured out on you through your relationships with others. Even the Samaritan shared the work of caring with the innkeeper! The work of loving that God calls us to is meant to be shared. Let's support one another, let's breathe together, let's pray with and for one another.

There is a lot of not-love abroad in the world. Let's be God's witnesses to love.

Greetings People,

We hope you can play with us on social media and engage with our Presbyterian Mythbusters! Our churches are stationed in a prime time of teaching and showing what it means to be a Christian and a citizen. **We want your questions and assumptions about what it means to be PRESBYTERIAN!**



One could be:

Politics has not place in the Pulpit - yes and no in our tradition!

Honestly, we know that 'politics' can be subjective for many of us. What is comforting for one may not be comforting for another and in the discomfort a possible assumption made is, 'that was too political'.

As Presbyterians and as religious organizations, we do not endorse candidates or election ballots from the pulpit. As Presbyterians we do hold elections for the spiritual leaders in our congregations who then are guided with Lord of Conscience in their leadership and faith for themselves and the congregation. As Presbyterians we recognize a shared similarity in order and privilege of governance through discerned and elected bodies (as reflected in our own Government system). And as Christians, Scripture is the authoritative Living Word of God and that the Testaments are God's self-revelation. That the Living Word is how we learn of God through Jesus, as in scripture and in life.

This is where for some the 'politics' can be subjective for us. Jesus' life points us to encounters with leaders and followers in times of health, wealth, governance, prisons, and grief. As disciples, we are guided to be with these situations and people so that all may know the love of God. When things get in the way of knowing this love (through people and life) we seek deep guidance of what we are called to do as children of God and citizens in the place we call home, in the building up of God's Kingdom. As Presbyterians, we are called to discern greatly! Here is a summary guidance of how we can rely with scripture as authoritative in our lives of citizenship\*:

1. Recognize that Jesus Christ, the Redeemer, is the Center of Scripture
2. Focus on the plain text of Scripture
3. Depend on the Holy Spirit's guidance for interpreting and applying God's message
4. Be guided by the Church's doctrinal consensus of "Rule of Faith"
5. Let all interpretations be in accord with the "Rule of Love"
6. Remember that Biblical interpretation requires earnest study
7. Seek to interpret a particular biblical passage in light of all of the Bible

May we be assured in the embrace of God's love and authoritative Living Word.

## Amendment Discernment Process



### Discerning Amendments 24A & 24C



General Presbyter John Molina-Moore facilitated a pre-presbytery discussion at 3:00 p.m. in Stone Hall.

All members of the NCP community were invited to participate. These proposed amendments were approved by the General Assembly last summer and are now among the thirteen items sent out to the presbyteries of the PCUSA for their consideration.

The Stated Clerk provided a brief presentation on the amendments: 24-A would add sexual orientation and gender identity to a list expressing the diversity of those united in Christ through baptism in F-1.0403. 24-C would amend the language of G-2.0401b, which addresses the examination of church officers, to require that the examination cover “the Historic Principles of Church Order (F-3.01), and ... the principles of participation and representation found in F-1.0403.” Currently, the Book of Order requires only that the examination address the requirements expressed in the constitutional questions asked of candidates at ordination and installation (W-4.0404).

The Stated Clerk noted that the affirmative votes of a majority of presbyteries would be required, in order for the amendments to be incorporated into the next edition of the Book of Order. Should this happen, he advised, it would be necessary for NCP’s Commission on Ministry to revise the set of questions in its examination policy that all candidates for ordination and membership are asked, in order to address the new requirements.

The General Presbyter invited participants to spend some time in groups discussing their fears or excitement around these proposed amendments, as well as their hopes for how NCP should implement them, if they are adopted. At the end of this time, the groups summarized their discussions.

Based on the discussion on September 24, the Leadership Council has decided to provide for an extended period of discernment before a vote by the presbytery on 24-A and 24-C, including the following:

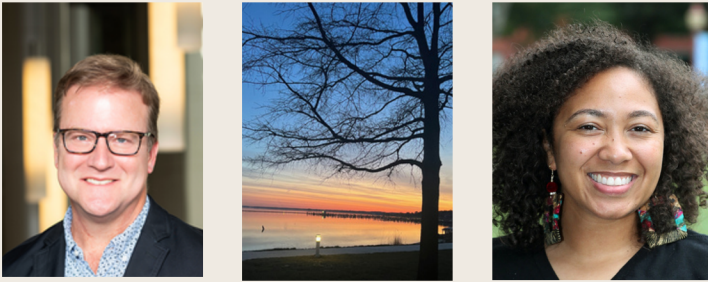

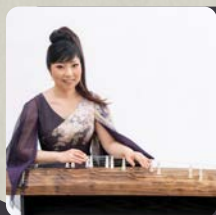
