ANNUAL STATISTICAL REPORT

The stated clerk has sent a notice to clerks of session that as of January 2, 2025, the Office of the General Assembly (OGA)'s statistical reporting system is open for the 2024 reporting season. We are asking churches to submit their reports by February 1, if possible. The absolute last day to enter statistical information is February 15. This is an OGA-set deadline, and NCP staff are not able to change it.

Beloved, do not believe every spirit, but test the spirits to see whether they are from God...

1 John 4:1a

Dear Friends,

The Presbyterian Church (U.S.A.) traces its heritage to a reforming movement, and has built into its governance a capacity and processes for ongoing reform. *Ecclesia reformata, semper reformanda* – the reformed church is always in need of reform, according to the Word of God. This disposition toward testing and refining our life as a church takes various forms, including in the description of the office of "ruling elder" in the *Book of Order*: "Ruling elders are so named not because they 'lord it over' the congregation (Matt. 20:25), but because they are chosen by the congregation to discern and measure its fidelity to the Word of God, and to strengthen and nurture its faith and life" (2.0301). (Think "ruler" in the sense of "measuring stick," not "command giver!")

Just as the Johannine church was called to test the spirits to ensure that they supported the church's God-given witness to Jesus as an enfleshed Messiah, the Presbyterian Church (U.S.A.) engages in an extended period of discernment and prayer to test the faithfulness of proposed amendments to the church's Constitution. When we consider changes to the way we organize ourselves and make decisions in the *Book of Order*, the following steps are required:

- A presbytery communicates an "overture" to the General Assembly, proposing a change. Under the current Book of Order, the overture must have the concurrence of another presbytery. Therefore, no change to the Book of Order can be considered by the General Assembly unless at least two presbyteries have agreed to it.
- 2. A number of advisory and advocacy committees elected by the General Assembly, including the Advisory Committee on the Constitution, analyze and offer feedback on the proposed amendment.
- 3. The proposed amendment is referred to one of the working committees at the next meeting of the General Assembly, which holds hearings and considers the proposal, possibly altering it or substituting a new proposal to achieve a similar goal.
- 4. The proposal comes to the floor of the full General Assembly where it is debated and may be further amended.
- 5. If approved by the General Assembly, the proposed amendment is communicated to all of the presbyteries of the PCUSA. At this stage, the proposed amendment can't be changed, but presbyteries have the opportunity to approve or disapprove it. If a majority of presbyteries approve within one year of the adjournment of the General Assembly, the amendment is incorporated in the next edition of the Book of Order.

I want to point out that every step I've described above takes place at one or more meetings, convened and adjourned with prayer, by a body of presbyters who have made solemn promises to carry out their ministry in obedience to Jesus Christ. That is a lot of serious, faithful testing of the spirits! And this doesn't even account for informal gatherings for discussion, individual prayer and study, and other forms of discernment that unfold outside of the formal process.

At our Stated Meeting on January 23, National Capital Presbytery will take part in the process of considering two proposed amendments to the *Book of Order*, Amendments 24-A and 24-C. (You can find a description of these, as well as the other amendments proposed in this cycle, in a booklet distributed by the Office of the General Assembly.) The Bills and Overtures Committee will be bringing the other proposals to the March Stated Meeting.) At this meeting we will reach the end of a time of discernment which began in September, when members of our community gathered in small groups for discussion, and which continued through other gatherings in October, November, and December.

Many thanks to those of you who have participated, and to those of you as well who have joined in prayer during this season. Thank you for voicing your questions, your excitement, your fears, and your hopes for the church, and for taking the time to listen to the voices of others. When I step back and see not only this presbytery, but other presbyteries coming together in a similar way and praying, talking, and listening toward being a more faithful expression of Christ's Church, I am awed and hopeful at the way the Spirit speaks to and through us!

"What does it mean to be WELCOMING?" This was asked by a youth leader at Silver Spring Presbyterian Church to her whole congregation. She began to reflect upon what this particular question meant to her as she attended a workshop at Keep Awake Youth Conference in Massanetta Springs Camp and Conference Center in November. She followed up with a deeper question, "Are we always welcomed?"

The impact of her naming, are we always welcomed, to her whole congregation caught my breath. I have not poked, yet, but I immediately caught the multi level ask in her question: as a youth in her church, as a young person in her daily grind of school and peers, as a young woman in the world today, as a brown skinned woman in the world today, as a 2nd generation immigrant in the United States today, as a Christian in the world today....

To be seen, heard, and known as the Lord our God knows us. This is humbling and can support each of us to be humbled as we will encounter uncomfortable welcoming situations, discussions, and opportunities this year. Being humbled by my own dis-comfort is a breath invitation to be closer with my God and ask for direction. This particular youth leaned directly into what she sees Jesus guiding us to be: a friend to the stranger AND a neighbor to ourselves.

As we begin this season of faith, please do look at your time and calendar! See the many opportunities we have within our presbytery to share the journey of dis-comfort and WELCOME, together. That is how we grow faithfully with the Spirit.

- Ask your colleagues who are in the Missional Incubator about their journey so far.
- Take prayer discernment time and read up on the <u>Amendments</u> we are to vote on this Presbytery Meeting, Jan. 23rd
- Join for a renewal in <u>Allyship training</u> that is IN-PERSON this February 8th at Lewinsville Pres.
- Gather with the many of us on Feb. 22nd for the NCP <u>Leadership Training</u> as we are blessed with Le Quan Turner and Paul Vasile for worship.
- And the annual NCP <u>Con-Ed event</u> for minister members and other church professionals, March 10th-12th (Tell your pastors to go!)

There are teams within our presbytery who are ready to connect and support your missional stretches regarding immigration, faithful politics, discipleship, youth ministry, and more. Just ask. We are not alone as we continue to navigate, join, and ask how God is compelling us to welcome and grow!

Shared Ministry Program

The new Shared Ministry Program encourages two or more Presbyterian Church (U.S.A.) congregations to covenant to create sustainable pastoral positions for ordained ministers. Participating congregations enter into a five-year dues incentive program with the Board to receive a subsidy of the cost of benefits for pastors. Shared Ministry is <u>not</u> a merger of churches; rather, it is multiple, individual congregations sharing a minister with a living wage and benefits that helps ministry flourish and be sustained for the long term. Assistance Program Updates

As part of our commitment to mutual care and wholeness, the Board of Pensions continues to expand access to grants through the Assistance Program to serve more ministers, employees, retirees, and surviving spouses who have financial need. In 2024, the Assistance Program distributed over 2,500 grants for a total of approximately \$8.5 million in funds. <u>Read about potential grant opportunities</u>.
