Dear Moderators and Clerks of Session,

In the Presbyterian Church (U.S.A.), we make decisions together, through ruling elders and teaching elders (or ministers of the Word and Sacrament) gathered in councils. While ruling elders and ministers have different roles in the church, when it comes to governance we participate equally, and in councils higher than the session, we strive for parity of representation. Ruling elder commissioners appointed by our sessions help us to benefit from the full diversity of our churches' leaders as we gather to make important decisions as a presbytery.

As instructed by NCP's "Policy on Ruling Elder Commissioners to Presbytery Meetings," I have put together an equalization plan for the next year, whereby each session is invited to appoint a certain number of ruling elder commissioners, so that the number of ruling elders who may participate is equal to the number of ministers on the membership roll of the presbytery. I invite you to share this information with your session, and to have them appoint ruling elder commissioners from your congregation for the year to come (May 2025 to April 2026).

A ruling elder commissioner must be an active member of your congregation who has previously been ordained as a ruling elder. The commissioner does not need to be currently serving on the session and may have been ordained by the session of another PCUSA congregation.

Stated meetings of the presbytery are generally held five times per year, on Tuesday evenings in January, March, May, September, and November. The current practice is to hold the May and September meetings in person at National Presbyterian Church, with the remainder of the meetings conducted over Zoom teleconference. The meeting schedule may be found on the [NCP web site](#). I would be pleased to speak with any new or potential new commissioner who might be curious about what this role entails.

While we encourage sessions to appoint commissioners for the full year, we understand that this may not always be possible. You might consider appointing alternates, in addition to the regular commissioners, so that the church can still be represented at presbytery meetings when particular people are unable to attend.
