Dear NCP Siblings in Christ,

It was a morning of narrative budgets, spreadsheets, and benefit and pension discussions. Thrilling, I know! Later our pastor told us that, in truth, the annual budget meeting might be the best service a newcomer could attend. What better way to see a congregation's heart than to see where they invest their resources? After nearly thirteen years, I suppose I can admit she was right.

Still, budgets can feel overwhelming — especially when the numbers aren't ideal. How do we balance faith in God's abundance with the reality of a deficit? How do we make sense of miracles when we're unsure how to sustain them once they occur? How do we practice faithful stewardship so that God's abundance isn't trapped in a mindset of scarcity? I imagine these are the same kinds of questions Stewardship and Finance teams hold tenderly as they care for their congregations' financial well-being.

Our National Capital Presbytery Budget and Finance Team has worked diligently to offer a faithful financial projection for 2026, and at our upcoming Presbytery meeting we will vote on that proposed budget. If you haven't already, I encourage you to watch the budget presentation before our meeting on Tuesday. You can also bring any questions or concerns to the **Action Item Dialogue** on **Monday, November 17, at 7:00 p.m.** on Zoom.

And if this will be your first meeting as a commissioner, welcome! Budgets, spreadsheets, and pensions might not sound exciting to everyone, but just as that first meeting at Oaklands turned out to be the best first meeting I could have attended, this might be the best first Presbytery meeting you could attend. If you find yourself overwhelmed by the discussion and tempted to log out, I hope you'll stay. See it as an opportunity to witness our shared commitment to transparency and faithful stewardship – a moment for the Spirit to move in and through us as we discern how to serve this Body well. Who knows, maybe in thirteen years you'll find me and tell me I was right — this was the best first meeting you could have attended.

Whether this is your first meeting or your fiftieth, my prayer is that we gather with care for one another and a willingness to move forward faithfully on the path God is calling us.

D.C. and Montgomery County, earning her Ph.D. in Speech-Language Pathology in 2006. Dr. Moore has been nominated to NCP's Personnel Committee and is excited about these opportunities to learn, serve, and become more involved in our presbytery.

Theological Spectrum: Moderate/Liberal

Please share what you believe are the key theological/social issues currently facing the church and society, and how they shape your experience in the church: People are struggling in their day to day lives. They are having difficulty in their belief in God, but rigid doctrines are not making them feel accepted as they are when they walk in the door.

Please indicate why you want to represent National Capital Presbytery at the General

Assembly: I attended many years ago as a young person. I found the procedures and the governance interesting. When amendments come to our presbytery, there is always something of a question of how GA arrived at the question and their response. To feel I can have an active part in the process excites me.

Le Quan Turner is a ruling elder at Westminster Presbyterian (DC), and currently serves

as a Commissioned Ruling Elder (CRE) at Adelphi Presbyterian. A graduate of Wesley Theological Seminary, she has served many roles in the presbytery, including as a seminary student intern at Faith Presbyterian, Minister for Community Life and pulpit supply at Northminster, and various other presbytery churches as pulpit supply. She has also served on Mission Coordination Committee, General Presbyter search committee,

and Leadership Council.

Theological Position: Liberal

Please share what you believe are the key theological/social issues currently facing the church and society, and how they shape your experience in the church: The Church, as the body of Christ, is called not only to proclaim the gospel but to embody it through radical love, justice, and inclusion...Systematic bias, the marginalization of women, people of color, LGBTQ+ persons, and the persistent misunderstanding of cultural differences remain wounds in the body of Christ that we cannot heal by mere comfort or polite conversation... To be Christ's Church is to be a community that not only welcomes all people but listens deeply, learns humbly, and transforms faithfully in response to the experiences of those long excluded. This means dismantling systems of privilege that distort our witness and reimagining our structures, language, and practices so that every person can flourish as a full image-bearer of God. The work is not easy, but it is holy.

Please indicate why you want to represent National Capital Presbytery at the General Assembly: My calling—and my voice—compel me to advocate for a Church that lives out the gospel not as an abstract ideal but as a concrete reality of justice and compassion...

The Spirit is already stirring in those places where the marginalized are being heard and

where transformation begins with listening. I hope for the Church to have the courage to follow that Spirit, toward a deeper, truer reflection of Christ's inclusive love. I am ready to be one of these listeners, to serve as an alternate to General Assembly as needed.

TEACHING ELDERS

Rev. Rachel Vaagenes, Vice-Moderator of NCP Teaching Elder, Capitol Hill Presbyterian Church



Rev. Rachel Vaagenes has been active in NCP for nearly 15 years, serving at Georgetown Pres for ten, and currently at the Capitol Hill Presbyterian Church. She served on the Nominating Committee for as long as Jacob labored in Laban's fields, and has also served on MCC. She has contributed to the refugee network, dismantling racism efforts, and NCP Pride events. She is the new Vice Moderator for this wonderful presbytery. She puts the "Bi" in "Pres-biterian," and cares deeply about making sure everyone feels welcome and knows that they are loved by God.

Theological Spectrum: Moderate/Liberal

What I believe are key theological and social issues facing the church: We are often told we need to choose between taking faith "seriously" or sacrificing our seriousness to allow for full acceptance for queer people...if we take our faith seriously, we will break down barriers and all find ourselves transformed by the grace of God. Another is the notion of community over individuality; also, how we place our faith in power and certainty rather than the vulnerability and openness of Jesus; creation care, consumerism, there's a lot of good work to do!

Why I want to represent NCP at GA: I love this presbytery and its people and I would be honored to serve in this way.

Rev. Elizabeth Brookens-Sturman Teaching Elder, Retired



Rev. Elizabeth Brookens-Sturman has served as a pastor in Berkeley, CA and Bethlehem, PA, before spending 20 years planting and leading the vibrant and growing Brambleton Presbyterian. In the presbytery, she has been a part of multiple task forces and policy writing initiatives and currently serves the New Things Team. Elizabeth has also been a part of various GA task forces and serves as a coach and consultant for the 1001 New Worshipping Communities movement. Prior to ordained ministry, Elizabeth was a social worker advocating for vulnerable children and youth in Dayton, OH.

Theological Spectrum: Moderate/conservative

What I believe are key theological and social issues facing the church: The current administration, the uneven global distribution of wealth, the apathy among wealthy nations to leverage our wealth to meet humanitarian crises, the rise of Christian nationalism and racism in the USA. Sadly our seminaries are not equipping pastors for the leadership needed. Yet there are signs of a spiritual re-awakening emerging especially from the global south and Great Britain. We must lean into our faith and press on.

Why I want to represent NCP at GA: As one who leans right theologically while simultaneously being committed to justice, I love the PCUSA and am a skilled bridge-builder. As a trained evangelist, I believe PCUSA's commitment to a "big tent" gifts us to call people who are far from God into faith-filled and Jesus-right-sized transformation anchored in the church and rooted in God's grace.

Rev. David A. Douthett Teaching Elder, Catoctin Presbyterian Church



Rev. David A. Douthett is the pastor of Catoctin
Presbyterian Church, where he has served since January
2004. Catoctin is working hard, like most other small
churches, to find what it means to bring the gospel into the
world in meaningful ways while extending God's Kingdom by
serving those in need. David has served on the Leadership
Council for NCP since 2022 and is on the Dismantling
Racism Team. He previously served on the Worship and
Theology committee and as a GA overture advocate. David
looks forward to bringing what wisdom he has gleaned in 35

years of ministry, a dedication to openness to the movement of the Holy Spirit, and an unbridled hope and faith in Christ's power to reform the Church for such a time as this.

Theological Spectrum: Moderate/Liberal

What I believe are key theological and social issues facing the church: The breakdown of the social norm of voluntary associations and organizations and the move to individualization; the polarization of our culture; Christian nationalism. My experience as a pastor in these days is one of managing people's anxiety by focusing on the sovereignty of God, the resurrection of Jesus Christ, and the call of the Holy Spirit. When everything seems to be coming apart, we do what the church is always called to do—be faithful, love all, serve and glorify Christ.

Why I want to represent NCP at GA: I believe I am reasonably typical of our presbytery in terms of theology and social outlook; as a solo pastor of a congregation with under 100 members, I can represent the interests of small churches. I have always found GA to be a fascinating enterprise, generally faithful and hopeful, even in the midst of turmoil.

Rev. Emma Horn Teaching Elder, Immanuel Presbyterian Church



Rev. Emma Horn is the Associate for Children and Youth at Immanuel Presbyterian Church. She also serves as the cochair of the Teaching Elder Care and Nurture Team of National Capital Presbytery and is part of the Presbytery's Youth leaders' group. She is involved in the greater denomination serving as a volunteer at the Montreat Youth Conference and Middle School Conference and as well as part of the 2026 Omega Youth Conference Planning Team. She deeply loves being Presbyterian and all of the hard and beautiful work that the General Assembly does.

Theological Spectrum: Liberal

Why I want to represent NCP at GA: Serving the greater church feels like an important part of my ministry and how I live into God's call. I love Presbyterian Polity and that we are a church reformed and always reforming, staying flexible to the call of the Holy Spirit.

Alternate: Rev. Charles Van Gorder Teaching Elder, At Large



Rev. Charles F. Van Gorder has been a Minister-at-Large member of National Capital Presbytery since 1996. He served as Stated Clerk from 1986-1988, has been on the Commission for Preparation for Ministry, and currently serves as the moderator of the Permanent Judicial Commission. Van has served with various churches including Church of the Pilgrims (former Parish Associate), Brentsville Presbyterian (former moderator), and has also taught Presbyterian Polity for Wesley Theological Seminary. For several years, Van is a

professional registered parliamentarian and has worked with the U. S. Department of Justice.

- New Growth Fund draw is lower due to PC(USA) grant of \$50,000 for the Missional Incubator Program.
- Pulled Mission Incubator expenses out of Seed Money for New Projects to allow greater transparency.
- Not using Mission Reserves to balance the Mission Budget for 2026. This allows reserves to be accessed for shortfalls in Unified Mission Giving.

MCC/CDC Expenses

- MCC and CDC again prepared a combined budget for 2026.
- Their combined expenses were reviewed against historic spending (2019-2024) and then the budget was aligned with that spending. This resulted in a 16.9% reduction in budgeted funds over 2025. At their committee meeting, we discussed the ways they could access additional funds if a project presented itself that they could not fund out of their budget.

Personnel Expense

- Personnel saw an increase in their budget to account for COLA and rising benefit costs.
- Increase in Mission Calibration to account for increased staff time and events that directly tie to Mission. We have not made a substantive increase in the Mission Calibration factor since its inception over 15 years ago.

2026 Mission Budget Motion

The Leadership Council recommends a \$992,964.16 mission budget for 2026.

• Increase due to desire to provide more workshops/training opportunities.

Middle Governing Body

- Insurance increases due to rising premiums and holding congregational property.
- Continuing Education Retreat moved out of budget as it is self-funding with support from Retreat
- Worship & Theology funding moved to Presbytery Events as previous funding was used primarily to support expenses associated with Presbytery Meetings and other NCP Gatherings.

Administrative Staff Costs

- Personnel budget reflects 1.35% COLA (COM recommended 2.7).
- Increase in Annuity & Health Insurance due to increase in insurance premiums.
- We anticipate a search for Stated Clerk in the first quarter of 2026 as well as having 2 staff up for sabbatical in 2026. Savings for vacant Stated Clerk position will likely be eliminated by paying part-time staff and moving expenses. Increase in supplemental expenses to hedge against that.
- Continue to practice unifying our budget by moving mission staff into operating and offsetting with a calibration.
- Mission calibration increased this year due to significant increase in staff time supporting mission related activities.
