# Administrative Commission for Warner Memorial Presbyterian Church

# National Capital Presbytery November 2024

During this season of Thanksgiving, it is with much gratitude to God that the Administrative Commission for Warner Memorial Presbyterian Church requests that National Capital Presbytery dissolve our commission at the November 19, 2024 meeting of the Presbytery, to be effective upon the adjournment of the commission's final meeting on December 8, 2024.

For the past 11 months the AC has spent significant and prayerful time listening to current and former staff members and members of the congregation, as well as elders and other church leaders, all in an attempt to better understand the conflict that had been experienced with the church's now former pastor. The AC had a listening session with the church's leadership team, the COM had listening sessions with members of the congregation, and the AC chair had several one-on-one conversations with the pastor. In the end, the AC discerned that, given the irreparable damage these relationships had suffered and the unlikelihood of achieving reconciliation, it was in the best interest of both the church and the pastor for the pastoral relationship to be dissolved.

Terms of the dissolution were easily agreed upon, and at a congregational meeting in August 2024 the pastoral relationship was dissolved. The AC, along with several elders from the church, then immediately began interviewing several extremely qualified candidates to serve as a Stated Supply pastor, and on October 1 the Rev. J.C. Cadwallader was hired.

Warner Memorial is a vibrant and faithful congregation, with gifted and capable people who are eager to serve. A new session is in the process of being trained; and they will be examined and installed at a joint congregational and AC meeting and worship service on Sunday, December 8<sup>th</sup>. Jurisdiction will be returned to the session at that time, and the AC is confident that by the grace of God, and under the capable leadership of J.C., Warner Memorial will move forward and thrive in the coming months and years.

# Report From the Administrative Commission on Congregational Property 9/20/2024

#### Important Information for Churches

#### G-4.0206 Selling, Encumbering, or Leasing Church Property from the Book of Order

#### a. Selling or Encumbering Congregational Property

A congregation shall not sell, mortgage, or otherwise encumber any of its real property and it shall not acquire real property subject to an encumbrance or condition without the written permission of the presbytery transmitted through the session of the congregation.

#### b. Leasing Congregational Property

A congregation shall not lease its real property used for purposes of worship, or lease for more than five years any of its other real property, without the written permission of the presbytery transmitted through the session of the congregation.

#### All leases executed by NCP Sessions must contain the following language:

"Notwithstanding anything contained in this Lease/License to the contrary, in the event that the Landlord as a religious organization is dissolved, Lessee or the National Capital Presbytery may terminate this Lease/License, provided that notice of such dissolution is provided to Lessee at least ninety (90) days prior to the anticipated date of dissolution, and (ii) the Lease/License shall not terminate for ninety (90) days after the date of such dissolution unless otherwise agreed by the Parties."

The Presbytery has empowered the Administrative Commission on Congregational Property with the powers of an Administrative Commission to consider and approve requests from churches to lease, sell or encumber the real property of a church. Any action in this regard by a congregation without the Presbytery's permission will not be recognized as legally valid.

Western Presbyterian Church (Washington, DC)

Heard and approved a request to enter into an MOU with Miriam's Kitchen allowing them to explore options related to expansion and renovations of their worship property.

Under its authority as an Administrative Commission of National Capital Presbytery (NCP), the Administrative Commission on Congregational Property (ACCP) grants approval for Western Presbyterian Church to enter into an MOU with Miriam's Kitchen stating their desire to explore options related to renovating and/or expanding the worship property located at 2401 Virginia Ave NW, Washington, DC. ACCP authorizes Heather Deacon, Director of Business Affairs/NCP Treasurer to sign said MOU. This approval and authorization contingent upon receipt of congregational approval of authorizing this action.

#### **Exams**

**Tyler-Williams, Angela** – sustained the examination of Rev. Angela Tyler-Williams on October 2, 2024 and recommend she be received as a minister member of National Capital Presbytery. [eVote October 8, 2024, pending ratification]

**Rodriguez, Adrian** – sustained the examination of examination of Candidate Adrian Rodriguez on October 7, 2024 and recommend he be received as a minister member of National Capital Presbytery pending ordination. [eVote October 14, 2024, pending ratification]

#### **Contracts/Terms of Call**

**Turner, Le Quan** – approved the agreement for Commissioned Ruling Elder Relationship between the session of Adelphi Presbyterian Church and CRE Le Quan Turner effective October 1, 2024 through September 30, 2025. [eVote September 17, 2024, pending ratification]

**Hwang, Yena** – approved the This eVote is to approve the Terms of Call between Yena Hwang and Falls Church Presbyterian Church, effective October 6, 2024. [eVote September 30, 2024, ratification pending]

**Manning, Peter** – approved the Stated Supply Contract between the Session of Lewinsville Presbyterian Church and Rev. Peter Manning effective for one year beginning September 22, 2024. [eVote October 14, 2024, ratification pending]

**Peace, Dwight** – approved the stated supply contract between the Rev. Dwight Peace and New Hope Presbyterian Church, for a period of four years, effective January 16, 2024, and subject to the following *exceptions* to NCP policy:

- A period of four years, exceeding the NCP policy limit of one year for stated supply contracts.
- Board of Pensions medical dues are waived, as the minister receives medical coverage through Tricare. (NCP Compensation Policy ordinarily requires medical benefits for a position with 20 or more hours per week. Under the Book of Order, medical benefits are required for installed pastors but may be waived for ministers in temporary pastoral relationships.)

[eVote October 22, 2024, ratification pending]

**Crawford, Adele** – approved the stated supply contract between the Rev. Adele Crawford and Chevy Chase Presbyterian Church, for a period of three months effective November 1, 2024, and

subject to an *exception* to NCP policy that requires medical and pension dues. [eVote October 30, 2024, ratification pending]

#### **COM Motions**

**Motion:** approved a waiver for Rev. Yena Hwang to be excused from a COM theological exam. Rationale: At a CTC meeting this summer, members discussed waiving the COM exam for Yena Hwang. CTC members indicated a willingness to waive the exam in this case but chose not to vote until the presbytery granted an exception. Current policy is that ministers who have been NCP members longer than 10 years are subject to repeat the COM theological exam. Yena is just one year over the 10 years since taking the exam for her call to Fairfax PC. If approved, the e-vote to waive the exam will allow Falls Church to vote on the call at a congregational meeting scheduled for October 6. The Session scheduled the congregational meeting pending presbytery approval of an exception, and CTC approval of the terms of call and the waiver. [eVote September 30, 2024, ratification pending]

#### **Commission on Preparation for Ministry**

The Commission met on November 4, and reports that it has:

- Conducted a final assessment of Candidate Kristin Franke (National) on October 30, and certified her ready for examination (G-2.0607).
- Received Hananiel Setiawan (Bradley Hills) as an Inquirer.
- Approved Inquirer Diane Maloney (Falls Church) to Candidacy for expedited process.
- Moved Inquirer VLC Vanlalhriatrenga (Gaithersburg) to Candidacy, via expedited process, pending receipt of documents.
- Approved a proposal to spend our remaining \$2,000 in scholarship money to distribute equally among those in the care process who are currently in seminary/taking classes.

Approve all committee chairs except Mark Eakin. The Leadership Council asks that the General Presbyter speak with him before it will consider consenting to his nomination to serve as chair of Bills and Overtures.

Next Blessing Fund: Funds came from the sale of Trinity Presbyterian Church, dedicated to ensuring that other churches did not reach this position. The language establishing the fund provides that it will revert to the general fund in November of this year. The staff has been exploring options for designating a purpose for this money.

One possibility: hire a pastor to serve on the presbytery staff, who will be assigned to do brief, intensive discernment work with churches. This person could also provide gap coverage to churches that are without a pastor.

MOTION: To propose the following AMENDMENT to the purpose of the Next Blessing Fund for approval by the presbytery. The current text is to be replaced with the following:

Next Blessings Fund This fund is established upon dissolution of Trinity Presbyterian Church, Bethesda, by action of the National Capital Presbytery at its November 18, 2014, meeting. This fund is to provide support for struggling churches through discerning their future sustainability. The fund will subsidize a presbytery staff position of a pastor/facilitator to work with churches is assessing their current and future vitality. This position will work with multiple churches, congruently, and provide realistic routes for

churches to pursue. These routes could include but will not be limited to; developing new community-based mission and ministry, redeveloping church property, merging with other churches, closing. Use of these funds will be approved by the Leadership Council. Any unused funds remaining in the "Next Blessings Fund" on September 24, 2029, will revert to the Board Designated Unrestricted funds of the Presbytery.

The General Presbyter provided a brief update on the Missional Incubator. Two cohorts have been formed and have begun working with Brian Clark.

Tara Spuhler-McCabe previewed the table discussions to be held at the September Stated Meeting as a follow-up to the Landscape survey that members of the presbytery community took in the spring.

Heather Deacon, the NCP Director of Business Affairs and Presbytery Treasurer, provided an update on the litigation to secure the property previously held by Garden Memorial Presbyterian Church, which was dissolved by the Presbytery last year. A member of the dissolved congregation made several motions to intervene, which were denied by the court. An attorney who had been opposing the Presbytery's claim has made a motion to withdraw from the case. It is not clear what party or parties he had been representing.

SC report. MOTION: To APPROVE the celebration of Communion during worship at the September Stated Meeting. Moved, seconded, approved.

Miriam Dewhurst spoke about the Matthew 25 Mini-Summit, which is sponsored by NCP's Dismantling Racism Team and Baltimore Presbytery.

Shani McIlwain expressed her appreciation for Miriam Dewhurst as chair of Leadership Council, and other members followed suit.

The meeting adjourned with prayer led by the Rev. Dr. Sterling Morse at 2:37 p.m.

#### MCC/CDC Expenses

- MCC and CDC again prepared a combined budget for 2026.
- Their combined expenses were reviewed against historic spending (2019-2024) and then the budget was aligned with that spending. This resulted in a 16.9% reduction in budgeted funds over 2025. At their committee meeting, we discussed the ways they could access additional funds if a project presented itself that they could not fund out of their budget.

#### Personnel Expense

- Personnel saw an increase in their budget to account for COLA and rising benefit costs.
- Increase in Mission Calibration to account for increased staff time and events that directly tie to Mission. We have not made a substantive increase in the Mission Calibration factor since its inception over 15 years ago.

## **2026 Mission Budget Motion**

The Leadership Council recommends a \$992,964.16 mission budget for 2026.

- Continue to practice unifying our budget by moving mission staff into operating and offsetting with a calibration.
- Mission calibration increased this year due to significant increase in staff time supporting mission related activities.
