#### **ACTION ITEMS FOR SEPTEMBER 25, 2025 NCP MEETING**

#### **ACTION ITEM #1**

#### Recommendation from the Commission on Preparation for Ministry

**MOTION**: The Commission on Preparation for Ministry MOVES that Connie Moore be allowed to enter the expedited candidate process according to the Book of Order G-2.0610 "When a Presbytery concludes there are good and sufficient reasons for accommodation to the particular circumstances of an individual seeking ordination, it may by three-fourth vote, waive any of the requirements for ordination in G-2.06, except G-2.0607d (ordination exams)."

<u>Note:</u> Approval of this accommodation requires a three-fourths majority. The Book of Order requires that the candidacy phase last at least one year (G-2.0602). The expedited process simply removes this time requirement.

<u>Rationale</u>: Connie has already completed her Master of Divinity degree from Union Presbyterian Theological Seminary, and she has passed the five ordination exams. CPM is recommending that we waive the one-year requirement so that she can be certified ready for ministry within the next year. She is a candidate in good standing with Catoctin Presbyterian Church and is under care of the National Capital Presbytery's Commission on Preparation for Ministry.

#### **ACTION ITEM #2**

#### **Recommendation from the Commission on Preparation for Ministry**

**MOTION:** The Commission on Preparation for Ministry MOVES that the Presbytery APPROVE alternate-means ordination exams for Ministry Candidate Nat Amarquaye according to Book of Order G-2.0610.

#### G-2.0610 Accommodation to Particular Circumstances

When a presbytery concludes there are good and sufficient reasons for accommodations to the particular circumstances of an individual seeking ordination, it may, by a three-fourths vote, waive any of the requirements for ordination in G-2.06, except for those of G-2.0607d. If a Presbytery judges that there are good and sufficient reasons why a candidate should not be required to satisfy the requirements of G-2.0607d, it shall approve by three-fourths vote some alternate means by which to ascertain the readiness of a candidate for ministry in the areas covered by the standard ordination exams. A full account of the reasons for any waiver or alternate means to ascertain readiness shall be included in the minutes of the presbytery and communicated to the presbytery to which an inquirer or candidate may be transferred.

The CPM is seeking approval of the following alternate exams for Candidate Amarquaye:

Theology Exam: The CPM will prepare a scenario in which Candidate Amarquaye will have a mock meeting with a church member who is considering becoming an elder. The meeting will include the member's questions about what Presbyterians believe and whether they can affirm those beliefs in getting ordained as an elder.

Worship and Sacraments Exam: The CPM will ask Candidate Amarquaye to plan and lead a worship service centered around a baptism, pointing to the meaning and importance of baptism as a sacrament in the Reformed tradition.

Note: Approval of these alternate-means examinations requires a three-fourths majority.

<u>Rationale</u>: Alternative exams are a way to support individuals for whom the written ordination exams have not been successful. As the PC(USA) Advisory Handbook on Preparation for Ministry states, "This provision recognizes written examinations are not appropriate means by which to assess some individuals' ministry competence" (p. 59). When individuals take the exams multiple times with the same result, it is our goal to support them in finding an alternate way to assess the same knowledge and pastoral readiness.

#### **ACTION ITEM #3**

#### Recommendation from the Leadership Council

**MOTION:** National Capital Presbytery agrees to redesignate the remaining amount of its \$159,156 donation to the Ministry Crisis Fund (approved at the March 2023 Presbytery Meeting) to the Ministry Crisis Fund 2.0.

#### Ministry Crisis Fund Background Information/Rationale

National Capital Presbytery's Ministry Crisis Fund (MCF) has been a staple in how the Presbytery walks alongside congregations and clergy in difficult times. For decades, it has primarily been funded through collections taken up at installations.

Recently, we became aware of a donor designation issue. The language in our Financial Policies lists the funds are to be used in the following manner:

ORIGINAL LANGUAGE: "The Ministry Crisis Fund is a longstanding financial resource which provides emergency assistance to ministers and/or their families when other resources are not sufficient. The fund is operated by Committee on Ministry. Income is primarily from the offering taken at all installation services. Assistance is provided in the form of grants or loans; where a loan is provided, ordinarily a promissory note is required."

At some point (likely 15-20 years ago), the following language began to be circulated through the Presbytery regarding how MCF monies were to be used:

CIRCULATED LANGUAGE: "The Ministry Crisis Fund is a longstanding financial resource of National Capital Presbytery. It has two purposes: To assist in responding to emerging crisis in the lives of clergy, church professionals and employees and others involved in our joint ministry. To assist congregations as they deal with emerging ministry crisis, primarily in the area of conflict involving staff and/or members."

It appears that all involved with the fund believed this language had been appropriately approved and NCP has been disbursing funds based on this 'updated' but unapproved language.

Because the donations are designated by the donor, the MCF is considered a donor-restricted fund. As such, any change in its designation must be approved by the donor. The Committee on Ministry, Leadership Council and Presbytery do not have any authority in changing the designation of these monies – only the donors are able to do that.

While the MCF is primarily funded through collections taken up at installations, at the March 2023 Presbytery Meeting, the body voted to designate funds from the dissolution and property sale of Riverdale Presbyterian Church for the MCF. The amount of those funds was \$159,156.

At Leadership Council's September 3, 2025 meeting, Leadership Council voted to create a new fund, Ministry Crisis Fund 2.0, using the circulated language above as its disbursement criteria.

The intent is to use the monies currently in the original MCF as indicated in its original fund language until such time that it is depleted. No new monies will be added to the original fund, all new collections will go into Ministry Crisis Fund 2.0 with its broader disbursement language. This will allow us to honor the original restrictions of the fund while enabling us to be responsive to the changing landscape of ministry.

In order to facilitate the depletion of the original fund (Ministry Crisis Fund) and provide monies for new fund (Ministry Crisis Fund 2.0), we respectfully request that National Capital Presbytery vote to redesignate the remaining amount of its donation made in March of 2023 into the Ministry Crisis Fund 2.0.

As of 8/30/2025, the balance in the original Ministry Crisis Fund is \$159,169.58. There is an additional \$18,000 in outstanding loans to the fund.

#### **ACTION ITEM #4**

#### Recommendation from the Leadership Council

Following the presentation of the first reading at the May 20, 2025 presbytery meeting, the Leadership Council MOVES the following amendment to NCP Standing Rule #3. (Text to be inserted is shown in *underlined italics*. Text to be removed is struck through.)

#### Standing Rule # 3 (SR-3)

#### A Special Rule of Order for the consideration of proposed amendments to the Book of Order

When proposed amendments to the Book of Order are before the presbytery for debate and vote, the Chairperson of Bills and Overtures Committee shall present the committee's judgment and recommendation in the form of a report, not a motion.

The committee's report may designate one or more amendments to be included in a consent agenda.

Following the presentation of the committee's report, an opportunity shall be given to any voting member of the assembly to remove items from the consent agenda for regular consideration. Once all such removals have been made, the Moderator shall declare that the items not removed have been answered in accordance with the committee's recommendations.

Immediately thereafter, the Moderator of the meeting shall <u>proceed with each of the items in the committee's report that the presbytery has not yet acted upon</u>, say<u>ing</u>:

"Amendment	_ is now before the presbyte	ry. (And, following discussion and debate, the N	/loderator
shall continue) A	ll in favor of Amendment	_ say "aye"; all opposed say "no". Amendment _	is
approved/is not	approved."		

The third option which is available, "take no action" would require a motion to the effect "I move that the presbytery take no action on Amendment \_\_\_\_" which would be made before the Moderator has called for the vote on the Amendment. It would be handled in the same manner as any main motion.

Rationale: The last two General Assemblies sent many proposed amendments to the presbyteries for consideration. As NCP engaged in discernment with respect to these proposed amendments, it emerged that only a small number required the careful review and debate of the whole body of the presbytery. To expedite voting on the amendments, the Bills and Overtures Committee each time recommended that the Standing Rules be suspended so that most items could be approved by means of a consent agenda. Suspension of the standing rules requires a two-thirds majority and is rightly perceived as a course deviating from the standard practice. The proposed amendment regularizes this process without abridging the right of any voting member of the assembly to require individual consideration, including a period of discussion, for any item presented by the Bills and Overtures Committee.

# Report From the Administrative Commission on Congregational Property 09/17/2025

#### Important Information for Churches

#### G-4.0206 Selling, Encumbering, or Leasing Church Property from the Book of Order

#### a. Selling or Encumbering Congregational Property

A congregation shall not sell, mortgage, or otherwise encumber any of its real property and it shall not acquire real property subject to an encumbrance or condition without the written permission of the presbytery transmitted through the session of the congregation.

#### b. Leasing Congregational Property

A congregation shall not lease its real property used for purposes of worship, or lease for more than five years any of its other real property, without the written permission of the presbytery transmitted through the session of the congregation.

#### All leases executed by NCP Sessions must contain the following language:

"Notwithstanding anything contained in this Lease/License to the contrary, in the event that the Landlord as a religious organization is dissolved, Lessee or the National Capital Presbytery may terminate this Lease/License, provided that notice of such dissolution is provided to Lessee at least ninety (90) days prior to the anticipated date of dissolution, and (ii) the Lease/License shall not terminate for ninety (90) days after the date of such dissolution unless otherwise agreed by the Parties."

The Presbytery has empowered the Administrative Commission on Congregational Property with the powers of an Administrative Commission to consider and approve requests from churches to lease, sell or encumber the real property of a church. Any action in this regard by a congregation without the Presbytery's permission will not be recognized as legally valid.

• Falls Church Presbyterian Church (Falls Church, VA)

June 18, 2025

Heard and approved a request to sell non-worship property.

Under its authority as an Administrative Commission of National Capital Presbytery (NCP), the Administrative Commission on Congregational Property (ACCP) **grants approval** to Falls Presby Church Presbyterian Church to sell their non-worship property at 209 E Broad Street, Falls Church, VA. <u>Approval contingent on receipt and review of all closing documents, purchase/sale agreement, review of intended purchaser's financials and appraisal as outlined in <u>ACCP Manual.</u></u>

Note: If the contracted sales price is less than \$1,068,750, FCPC will return to ACCP for subsequent approval.

ACCP authorizes NCP Treasurer to review all closing documents, clear contingencies, and sign all documents on behalf of National Capital Presbytery.

• Knox Presbyterian Church (Falls Church, VA)

July 17, 20205

Heard and approved a request to obtain a loan against its worship property for the purpose of renovations associated with launching a preschool/daycare.

Under its authority as an Administrative Commission of National Capital Presbytery (NCP), the Administrative Commission on Congregational Property (ACCP) **grants approval** to Knox Presbyterian Church to borrow \$330,000 from the Investment & Loan Program of the Presbyterian Foundation for a term of 20 years with an initial rate of 5.35%, adjustable every 5 years. Loan to be secured by first mortgage on worship property located at 7416 Arlington Blvd, Falls Church, VA. The purpose of the funds is to renovate the building in order to launch a preschool/daycare. *Approval is contingent upon receipt of congregational resolution approving the project and loan as well as signed Certificate of Agreement with NCP Loan Guarantee Policies.* 

ACCP further authorizes Senior Director of Finance & Operations to sign on behalf of the Presbytery in her capacity as Corporation Treasurer.

• Rockville Presbyterian Church (Rockville, MD)

July 17, 2025

Heard and denied a request to sell non-worship property. Notification of denial included alternative options for consideration to congregation.

Under its authority as an Administrative Commission of National Capital Presbytery (NCP), the Administrative Commission on Congregational Property (ACCP) <u>denies</u> a request from Rockville Presbyterian Church to sell their non-worship property located at 215 W Montgomery Ave, Rockville, MD.

• First United Presbyterian Church of Dale City (Woodbridge, VA)

July 17, 2025

Heard and approved a request to obtain a loan against its worship property for the purpose of a new HVAC System, solar panels and other renovations.

Under its authority as an Administrative Commission of National Capital Presbytery (NCP), the Administrative Commission on Congregational Property (ACCP) **grants approval** to First United Presbyterian Church of Dale City to borrow \$350,000 from the Investment & Loan Program of the Presbyterian Foundation for a term of 20 years with an initial rate of 4.289%, adjustable every 5 years. Loan to be secured by first mortgage on worship property located at 14391 Minnieville Road, Woodbridge, VA. The purpose of the funds is to replace HVAC, upgrade lighting, replace carpet in sanctuary and install solar panels. *Approval is contingent upon receipt of congregational resolution approving the project and loan as well as signed Certificate of Agreement with NCP Loan Guarantee Policies*.

ACCP further authorizes Senior Director of Finance & Operations to sign on behalf of the Presbytery in her capacity as Corporation Treasurer.

• Leesburg Presbyterian Church (Leesburg, VA)

August 26, 2025

Heard and subsequently approved request to enter into a 10-year power purchase agreement to include installation of solar panels on its worship property.

Under its authority as an Administrative Commission of National Capital Presbytery (NCP), the Administrative Commission on Congregational Property (ACCP) grants approval for Leesburg Presbyterian Church (LPC) to enter into a

10-year power purchase agreement with Sunspots, to include the installation of a solar panel system on the church roof with final approval contingent upon inclusion of provision in contract specifying inspections and maintenance will not be performed during worship services, review of purchase agreement by LPC legal counsel, receipt of contractor liability insurance, and approval by local government and/or review boards.

• Gaithersburg Presbyterian Church (Gaithersburg, MD)

August 26, 2025

Heard and approved a request to enter into an MOU with <<NAME WITHHELD FOR CONFIDENTIALITY PURPOSES>> to explore possibility of opening a 24-hour emergency shelter.

Under its authority as an Administrative Commission of National Capital Presbytery (NCP), the Administrative Commission on Congregational Property (ACCP) **grants approval** to Gaithersburg Presbyterian Church to enter into an MOU with << NAME WITHHELD FOR CONFIDENTIALITY PURPOSES >> stating their desire to explore options related to renovating and opening a 24-hour emergency shelter at worship property located at 610 S Frederick Ave, Gaithersburg, MD. <u>Approval contingent upon the receipt of congregational approval authorizing this action.</u>

ACCP further authorizes Senior Director of Finance & Operations to sign on behalf of the Presbytery in her capacity as Corporation Treasurer.

The Leadership Council APPROVED the docket and the Minutes of the May Leadership Council Meeting. The Leadership Council RATIFIED the eVote approval of the Memorandum of Understanding between National Capital Presbytery and Christ the King Presbyterian Church regarding the use of the property formerly held by Northwood Presbyterian Church. The text of the Memorandum is attached to these minutes.

The Leadership Council of National Capital Presbytery held a **special meeting** via Zoom teleconference on June 18, 2025. The meeting was called by the chair, the Rev. Jeri Fields, for the purpose of acting on a recommendation from the NCP Treasurer. Rev. Fields called the meeting to order with prayer at 12:31 p.m.

Rev. Fields recognized the NCP Treasurer, Heather Deacon, who presented the following recommendation:

As reported at the June Leadership Council meeting, our attorney recommends we record the deed in our name (based on the March ruling) while we wait to hear if the Court of Appeals will grant Mr. Gray standing. Despite the order reading that fees relating to the recording of the deed should be waived, DC Recorder of Deeds will not record the deed without payment of the fees. Our attorney recommends that we pay the fees under protest and then work to have them refunded. The fees amount to \$164,108.10 (based on a tax assessed value of \$5,658,900.00).

We do not have sufficient funds in the Property Management Fund to pay the total due. Additionally, given we are currently paying upkeep on the Northwood Presbyterian Church property, it is unwise to drain the Property Management Fund. Therefore, I recommend that we pay the full amount of the fees out of the Office Fund and then reimburse the Office Fund when either the fees are refunded or the property sells, whichever happens first. The Office Fund is advisable because it has sufficient funds AND because it falls solely under the direction of Leadership Council (meaning Leadership Council has the authority to designate the funds).

Below is relevant financial information to assist in decision making:

Property Management Fund – Replenished by proceeds of property sales, up to a threshold of \$350,000. Balance as of April 30: \$156,472.07

Office Fund – Replenished by vote of Presbytery. Annual draw supports official business of the Presbytery and minimizing per capita increases. Balance as of April 30 (included deduction of 2025 budget draw of \$110,000): \$461,968.31

Garden Memorial Expenses Year to Date: \$125,868.55

Garden Memorial Expenses 2022 -2025: \$434,549.12

Rev. David Baer, the Stated Clerk, suggested language for a motion that was made and seconded. During the discussion, an amendment to the motion was adopted, and the final form of the motion is given below:

<u>MOTION</u>: That the Leadership Council AUTHORIZE the expenditure of \$164,108.10 from the Office Fund for the full amount of the fees related to recording the deed for Garden Memorial Presbyterian Church, with the funds to be reimbursed to the Office Fund when either the fees are refunded or the property sells, whichever happens first.

Following the period of discussion, the Leadership Council VOTED to approve the motion.

Rev. Fields adjourned the meeting with prayer at 1:00 p.m.

#### WORSHIP

The Presbytery proceeded to worship God, led by the General Presbyter, the Rev. John Molina-Moore, preaching, and the Rev. Billy Kluttz, Pastor of First Presbyterian Church of Arlington, providing musical accompaniment. The Presbytery celebrated the Lord's Supper, with Rev. Molina-Moore presiding.

#### TRANSITIONS / PRAYERS OF INTERCESSION

Following worship, the Moderator, Elder Durden, assumed the chair again and recognized the Rev. John Molina-Moore, General Presbyter. Rev. Molina-Moore called attention to coming events and recent transitions in the life of the Presbytery, inviting the Rev. Brian McCollum, Stated Supply Pastor at Sargent Memorial Presbyterian Church, to address the assembly, and noting the retirement of the Rev. Susan Wilder (specialized ministry). Rev. Molina-Moore led the assembly in prayer.

#### REPORT OF THE NOMINATING COMMITTEE

The report of the Nominating Committee was presented by the chair, the Rev. Patrick Hunnicutt. On behalf of the committee, Rev. Hunnicutt placed in nomination:

• Elder Jesy Littlejohn (Oaklands), for the office of Moderator (Sept. 2025-Sept. 2026)

The Rev. Rachel Vaagenes, for the office of Vice Moderator (Sept. 2025-Sept. 2026)

There were no nominations from the floor. Upon a motion properly made and seconded, the Presbytery voted that the nominations be CLOSED, and those nominated by the committee were thereby ELECTED. The Moderator and Vice Moderator will be installed at the September Stated Meeting.

Rev. Hunnicutt informed the Presbytery that the Nominating Committee was seeking ruling elders and teaching elders to serve as commissioners to the 227<sup>th</sup> General Assembly in 2026. He invited those who might be interested in serving in this role to get in touch with the Nominating Committee.

The Moderator offered a prayer of thanksgiving for the work of the Nominating Committee.

#### REPORT OF THE COMMISSION ON MINISTRY

The Rev. Juli Wilson-Black presented the commission's report. On behalf of the commission, she moved the following:

**MOTION:** The Commission on Ministry, pursuant to Book of Order G-2.0504(c) and the Presbytery's Policy on Changes in Pastoral Roles within a Congregation, recommends that the Presbytery **GRANT** an **EXCEPTION** to allow the Rev. Lisa Larsen, who is currently serving as an Associate Pastor (Stated Supply) at National Presbyterian Church, to be eligible to be called and installed as Associate Pastor.

#### NOTE: Approval of this exception requires a three-fourths majority.

<u>Rationale</u>: The Book of Order states that a pastor serving in a temporary pastoral relationship is "ordinarily" not eligible to become the installed pastor (G-2.0504b), but allows the presbytery to grant an exception by a three-quarters vote (G-2.0504c). The NCP Policy on Changes in Pastoral Role provides a process whereby the CTC is able to bring such a recommendation for a minister who has been serving for at least 12 months.

The Rev. Lisa Larsen began serving as Associate Pastor (Stated Supply) for Care in February 2022. In accordance with this policy, Rev. Larsen communicated her request in writing and consulted with representatives of the CTC, which then approved the request to explore this change in pastoral role and advised the session on conducting a discernment process with the congregation of National Presbyterian Church. This discernment process was completed in March, and the session reported the results in a letter to the CTC.

The session reports that in her more than three years of service at the church, Rev. Lisa Larsen "has cultivated strong relationships with members of NPC. Many members express gratitude for her guidance, support, and compassionate care. During her tenure she has revitalized our Deacon ministry, established a vital Prayer Team, and restarted the impactful Grief Support program for those experiencing profound loss. ... Comments received from congregants and staff ... confirm that members of the NPC community do not view Lisa as a temporary pastor. Indeed, numerous participants in the discernment process have expressed surprise that she is not already an installed pastor. Accordingly, we believe that members and staff alike would enthusiastically welcome her becoming a called-and-installed pastor at NPC and would have no difficulty adjusting to her transition from a temporary pastoral role to an installed position." The session also noted its desire to support and continue the initiatives Lisa has undertaken, and weighed her strong performance in her role against the uncertain possibility of finding an equally satisfactory candidate in an open search.

For these reasons, the COM recommends that the Presbytery grant the requested exception.

Following a period of discussion, the Presbytery **VOTED** to **GRANT** the exception, by the required three-fourths majority.

The Moderator recognized the Rev. Carla Gorrell, co-chair of the Commission on Ministry, who spoke briefly about the work of the COM. She highlighted opportunities for "wellness visits," which allow sessions to share their successes and challenges with the presbytery outside of the context of a pressing problem. She spoke of the work of the COM in guiding churches through transitions in pastoral leadership, and of the various working teams responsible to the COM. She asked that in the event of conflict, churches contact the presbytery early for support. She reminded pastors to seek the approval of COM before sabbaticals and for changes in pastoral role. Pastors who are retiring or otherwise departing should consult with the General Presbyter, who will work with the COM.

#### REPORT OF THE LEADERSHIP COUNCIL

The Moderator recognized the Rev. Jeri Fields, the chair of the Leadership Council. Rev. Fields presented a proposed amendment to the Presbytery's Standing Rules for a first reading:

#### Standing Rule # 3 (SR-3)

#### A Special Rule of Order for the consideration of proposed amendments to the Book of Order

When proposed amendments to the Book of Order are before the presbytery for debate and vote, the Chairperson of Bills and Overtures Committee shall present the committee's judgment and recommendation in the form of a report, not a motion.

The committee's report may designate one or more amendments to be included in a consent agenda.

Following the presentation of the committee's report, an opportunity shall be given to any voting member of the assembly to remove items from the consent agenda for regular consideration. Once all such removals have been made, the Moderator shall declare that the items not removed have been answered in accordance with the committee's recommendations.

Immediately thereafter, the Moderator of the meeting shall <u>proceed with each of the items in the</u> committee's report that the presbytery has not yet acted upon, saying:

"Amendment is now before the presbyte	ry. (And, following discussion and debate, the Mo	derato
shall continue) All in favor of Amendment	_say "aye"; all opposed say "no". Amendment	_ is
approved/is not approved."		

The third option which is available, "take no action" would require a motion to the effect "I move that the presbytery take no action on Amendment \_\_\_\_" which would be made before the Moderator has called for the vote on the Amendment. It would be handled in the same manner as any main motion.

<u>Rationale:</u> The last two General Assemblies sent many proposed amendments to the presbyteries for consideration. As NCP engaged in discernment with respect to these proposed amendments, it emerged that only a small number required the careful review and debate of the whole body of the presbytery. To expedite

voting on the amendments, the Bills and Overtures Committee each time recommended that the Standing Rules be suspended so that most items could be approved by means of a consent agenda. Suspension of the standing rules requires a two-thirds majority and is rightly perceived as a course deviating from the standard practice. The proposed amendment regularizes this process without abridging the right of any voting member of the assembly to require individual consideration, including a period of discussion, for any item presented by the Bills and Overtures Committee.

In accordance with Standing Rule #1, any amendments to the proposal offered at this meeting—along with less formal feedback—will be referred to Leadership Council for consideration. The proposed amendment will be presented for final approval at the September Stated Meeting.

A period for questions and feedback was offered. In accordance with Standing Rule #1, no action was taken at this meeting.

**NEW BUSINESS** 

No new business was offered.
